In the two parts of this essay, Maria Erling and Susan Wilds McArver argue that American Lutherans recognized and acted upon a new moment of freedom within their churches to adapt new interpretations of Lutheran scripture in regards to women's ordination. Maria Erling, a scholar of modern church history, details in Part I the debates leading up to the decision to ordain women. She particularly emphasizes the context of a changing American culture, and how the opinions of increasingly more educated and suburban Americans influenced the church. Also, she highlights two sides of ecumenicism in these debates, as American Lutherans wanted to catch up to their European counterparts but also maintain relationships with the Lutheran Church – Missouri Synod. To show the variety of voices in the debate, Erling draws upon Lutheran journal articles from the time. In Part II, Susan Wilds McArver, a church history professor with interests in women's history, describes the conventions that officially recognized women's ordination. She concludes by discussing the Lutheran Church – Missouri Synod and its negative reception of the ordination decision and the deterioration of ecumenical advances. McArver draws upon institutional reports to display the opinions leading into the deciding conventions. She also makes space to discuss the opinions and voices of Lutheran women during the time of the decision, which are often ignored in the discourse of this decision.

Gracia Grindal – a professor of rhetoric, English and theology – examines Lutheran theologians' hermeneutical arguments concerning women's ordination and the conflict these interpretations created. She examines these arguments to evaluate the causes of a Lutheran theological debate about the changing role of the pastor. She primarily draws upon theological articles in Lutheran journals and official reports prepared by Lutheran seminaries and church organizations. The article follows a chronological timeline of the debate and details the evolution of interpretations put forth only in the time before the decision. Throughout, Grindal also highlights the ecumenical impact of this debate, particularly regarding relationships with the Lutheran Church – Missouri Synod.

Krister Stendahl, a Swedish theologian and New Testament scholar, originally wrote this booklet in 1958 to contribute to theological debates about the ordination of women in the Church of Sweden. The culmination of the booklet is Stendahl's conclusion that the question of women's ordination is inextricably linked with the problem of women's emancipation in general. Stendahl argues that, if emancipation of women is right, then there is a lack of biblical reason against women's ordination. To support this final conclusion, Stendahl gives detailed explanations of the Swedish practice of "realistic interpretation" of the Bible and its interactions with hermeneutics. He also discusses complications surrounding the use of this realistic interpretation when applied to several key New Testament passages often used in the discussion of women's ordination. This version of the booklet is written for an American audience – translated into English with additional explanations of elements of Swedish culture and religious institutions. Stendahl uses the example of Sweden as a case study from which Americans can learn ten years after the booklet's initial publication. This work is acknowledged by many for its influence and relevance in the debate surrounding women's ordination.

Raymond Tiemeyer, a Lutheran pastor and editor of many works about the Lutheran church, wrote this book as a condensed digest of research presented in 1970 by the Division of Theological Studies of the Lutheran Council in the U.S.A. Tiemeyer takes the 123-page report by the Division of Theological Studies and restructures it into a 50-page booklet aimed at a general Lutheran audience. He summarizes the findings of the research – mainly that there is inconclusive evidence in scripture supporting both the arguments for and against the ordination of women. The chapters divide the research findings into scriptural arguments, hermeneutical complications, historical precedent, and the practical considerations for the implementation of women's ordination. In all, Tiemeyer reflects the Division's conclusion that the scripture allows for a variety of interpretations. The appendix of the booklet reprints the official summary of the

Division's findings – the Statement of Findings Relating to the Requested Study on the Subject of the Ordination of Women. There is also a bibliography at the end, including additional sources from books, articles, essays, and other study reports.
